Approval of the Agenda

New Business

Consultant Agreement for SCADA Services

Public Works Director Dave Sukau went over the staff report. He explained SCADA stands for Supervisory Control and Data Acquisition. This is the common name for the control systems for water plants, wastewater plants and pump stations, as well as for private industry manufacturing systems. A SCADA system consists of controllers which are industrial computers or PLCs (programmable logic controllers) and HMI (Human Machine Interface) software packages also referred to as graphic user interfaces (GUIs) and various other names. These two components work together to provide the supervisor control portion of the SCADA system. The data acquisition is often a part of the HMI system or an add on to it. Data acquisition is more commonly referred to as data logging or trending. This is used to log information that is required to be reported to regulatory entities. For the Water Plant this includes things like flow rates, reservoir level chlorine dosage rates, chlorine residuals, raw water turbidity and so on. The City needs a SCADA system to allow for automatic operation of the water plants, pump stations and wells and to allow for those systems to operate 24/7 even when they are not staffed. SCADA systems need to be updated periodically for many reasons. SCADA, GUI or HMI software run on normal desktop style computers and servers. This hardware has a life cycle of about 5 years. The software operating systems are usually supported by the manufacturer (Microsoft) for 3 to 5 years as well. The SCADA computers currently in use at the water plants are approximately 15 years old which is two to three times the recommended life expectancy. These systems are running on Windows XP. Windows XP has been discontinued by Microsoft and is no longer supported. Known security vulnerabilities of windows XP have prompted many entities to demand such systems not be in use anywhere in the City or the manufacturing plant and specifically that they are never connected to the internet. Most exploitation of windows XP vulnerabilities happen via the Internet. PLC hardware and software systems must be updated periodically as well. Manufacturers stop supporting the hardware and software after a certain amount of time and some components become unavailable altogether. The life expectancy of PLC control hardware is in the range of 20 years. The Miller Road plant is two thirds (2/3) of the way through this life span and the Keys Road water plant is well past it. In order to progress forward with the City's needed SCADA System update, staff prepared and advertised a Request for Oualifications (RFQ) to solicit qualified consulting teams to complete the project. The RFQ was issued on June 28, 2019 and responses were received on July 25, 2019. A final recommendation from the Selection Committee was made on August 1, 2019, to enter into a contractual agreement with Industrial Systems Inc. The anticipated total cost of implementing a new SCADA System for the Water Treatment Plant is \$224,040.00. Due to budget constraints, this project will need to be completed in phases over FY's 2019-2020 and 2020-2021. For FY 2019-2020, the City plans to complete tasks one (1) through five (5). He explained staff recommends Council authorize the City Manager to enter into a contractual agreement with Industrial Systems Inc., to complete SCADA Services for the Water Treatment Plants.

Council President Kessi explained he noticed on the bid that labor is more than half the cost. He asked is it a not to exceed price?

Public Works Director Dave Sukau replied it is not a not to exceed, it can be, however these are estimates that they feel are conservative. He explained we believe that the work will come in under these amounts. He explained we have budgeted for this over a two year period.

Council President Kessi explained he would just have that as a note of concern, that it is not to exceed. He asked if they have a good warranty program.

Public Works Director Dave Sukau replied each component has its own warranty per manufacturer. He talked about having flexibility, this is not set in stone, as they have not put together the hard estimates of what these components are truly going to cost, they are based on historical pricing. He explained the City has a long history with this particular company.

Treatment Plant Supervisor Darryl Sykes explained we have some desktops that are running on XP and should something happen we will need to work something out. He explained another difficulty is just the plants themselves, even though they speak to each other it is not a seamless connection. He explained he thinks this is necessary.

Councilor Poling asked if the company they are going with are the only ones who could work on this if anything goes wrong?

Public Works Director Dave Sukau replied, in a phone call, we could have anybody come take over this.

Councilor Sanders moved, and Councilor Poling seconded the motion that Council authorize City Manager Sykes to initiate the SCADA Services Project and enter into a contractual agreement with Industrial Systems Inc to complete SCADA Services for the Water Treatment Plants. Motion passed (6-0). Mayor Burge, aye; Council President Kessi, aye; Councilor Sanders, aye; Councilor Haugen, aye; Councilor Poling, aye and Councilor Lesowske, aye.

Presentation by Chief Miller

Chief Miller explained Timmi Sue has been with the Scappoose Police Department for a little over a year. He explained Timmi Sue has done a phenomenal job and continues to go above and beyond. He explained he gave Timmi Sue the project of National Night Out and not only did she go above and beyond, she stayed in budget. He gave her a certificate of appreciation for an outstanding dedication to National Night Out. Congratulations Timmi Sue!

Resolution No. 19-17: A Resolution Approving Sale of City Owned Real Property

City Manager Michael Sykes explained a couple of months back we talked about a surplus piece of property that the City has, and we had a property owner that was interested in purchasing it.

City Planner Laurie Oliver went over the staff report. She explained the City of Scappoose owns two 0.29-acre parcels of vacant real property located south of the NE 3rd Street and Crown Zellerbach Road intersection, known as Columbia County Tax Assessor's Map No. 3N2W12AB

300. Both parcels are bisected by a public road, NE 3^{rd} Street, and have no development potential unless a portion of one of the parcels is conveyed through a property line adjustment to an abutting landowner. On May 6, 2019, City Manager Sykes presented to Council a written offer to purchase a ~3,484 square foot portion of the City property from an adjacent landowner, to which Council counteroffered and granted the City Manager permission to negotiate a higher price for the City property. On May 20, 2019, City Manager Sykes informed Council that an agreement for the price of the City property had been reached of \$15,000 + the cost to process the necessary property line adjustment. In accordance with ORS 221.725 and 271.310, notice and opportunity for the public to comment on the proposed sale of the City property has been provided (public notice was provided in the August 23^{rd} edition of the Spotlight), and no comments from the public have been received. The buyer offered to purchase the property so that his frontage along NE 3^{rd} Street is increased, thereby allowing for a partition of the enlarged lot to permit the construction of a tri-plex and four-plex. This would allow the property to return to the tax rolls and will support the provision of needed housing in Scappoose. Staff recommends that the Council adopt Resolution 19-17 as presented.

Mayor Burge opened the public hearing at 7:17 p.m. and closed due to no one wanting to speak on this matter.

Councilor Sanders moved and Councilor Haugen seconded the motion that Council adopt Resolution 19-17 as presented. Motion passed (6-0). Mayor Burge, aye; Council President Kessi, aye; Councilor Sanders, aye; Councilor Haugen, aye; Councilor Poling, aye and Councilor Lesowske, aye.

Columbia County Tourism Initiative



Mayor Burge explained this was a good process and he is glad that we are where we are today. He asked what other entities has Alison talked to?

Alison Hart replied just Clatskanie and the County Commissioners. She explained they will have to go back to the County Commissioners because they wanted more information.

Councilor Haugen stated to Alison that she has done a really nice job of this and it was a good presentation. He stated it is useful to consider that as an economic sector, tourism is probably the only one that is not going to be adversely affected by artificial intelligence. Alison Hart replied there are three different grant types specifically through Travel Oregon but there are numerous other tourism related grants that we can look into.

Mayor Burge went over the calendar.

City Manager, Police Chief, Councilors, and Mayor

City Manager Sykes stated to Councilor Sanders it has been an absolute privilege to work with her and thanked her for her services and stated he wishes her the best. He mentioned the Sauerkraut Festival is coming up on the 14th and it has been an amazing effort between the Community Club and the Economic Development Committee members who have been helping with that. He explained there are 110 booths that have already signed up, and it should be really a great event. He stated hats off to Susie Wilson who has spearheaded all of this. He explained the 30-inch sewer line that is going to serve the eastside of the airport will begin in about two weeks. He explained the Port has finished the sewer and water line to the west side of the airport and made those connections. He explained staff is continuing to work on the candle easement and Laurie has done a great job of negotiating that on the City's behalf. He mentioned the Dutch Canyon well is finally online.

Public Works Director Dave Sukau explained there was a portion there that was too shallow, so they had to replace about 300 feet of it and in that process, they had to shut it down and ended up having some difficulties doing that. He stated it has been a challenge for the water department.

City Manager Sykes explained then all of a sudden we were not getting the water volume, so staff met because that is fairly significant. He stated the good news is Dutch Canyon came online and that added a couple hundred gallons a minute. He explained staff was able to clean out South Fork dam which increased the capacity there. He explained because of the good planning the City has done we are able to meet the demand. He explained because of the Chief's Code Enforcement Officer we have been making a difference around the City addressing the code violations.

Chief Miller thanked Councilor Sanders for her service to the City. He explained school has started and the kids are out running around and riding their bicycles. Please make sure to watch out for the kids. He explained the Annual Suicide Walk is on September 21. He explained it is another event that keeps growing and exceeds our expectations.

Councilor Poling wished Councilor Sanders good luck and said it has been very nice serving with her. He thanked Chief Miller for being out this morning and helping. Everyone saw the Police Force out in the school zones and that helped to remind everyone that school started today.

Council President Kessi thanked Councilor Sanders for her service and making the motions. He explained he also appreciates her well balanced approach to the issues they have considered. He stated good luck in the future.

Councilor Sanders explained she will be relocating so this will be her last meeting on the Council. She stated it has been really fun and interesting and she has learned a lot. She stated all the Councilors are great, and the City staff you are amazing, and made her job easy. She thanked Councilor Haugen and said he is the reason she is here because he put this thought in her mind and it worked out and has been fun.

Councilor Haugen explained Councilor Sanders was a former student and he is going to miss her. He talked about a committee that Mayor Burge formed regarding the Fuel Tax.

Councilor Lesowske wishes Councilor Sanders the best in all that she does. He does think her taking the call to serve the City of Scappoose over the last few years speaks of her character and dedication and he wishes her the best.

Mayor Burge gave an overview of the Political Action Committee he formed.
