Interim City Manager Rains explained we have our continuation of the review of goals. She went over the 2020-2021 Council Goals & Objectives.

Interim City Manager Rains replied the idea is that we will work up a scope of work and bring that to Council for review.

Councilor Lesowske asked how are we measuring this as a way to know what that outreach is? He asked are we tracking it on each of these different communication outreach tools to say how many folks are we able to connect with over the year through this particular means of communication. He asked is that something we feel is being of value to show that the communication is actually getting out.

Interim City Manager Rains replied she is not sure if there is necessarily a good way to specifically track it. She explained the newsletter is going out in the utility bills and how much of that people are actually reading she couldn't exactly say. She explained we do get some traffic on Facebook. She stated that might be easier to track with the app.

Chief Miller replied yes, it will be easier because the app will track the data.

Councilor Lesowske stated he will let staff decide if there is value in it, but he thinks looking at the analytics to understand if there is value in what we are doing or is there potentially a more appropriate communication outreach that we should be zoning in on or looking into. He stated he thinks having the app will be an additional one that will reach a wider audience. He thinks having a variety of outreach in addition to a strategic communication approach.

Chief Miller explained the app will be launched probably the second week in January. He talked about survey's being a good way to measure community involvement.
