#### Introductions

Council reviewed the goal lists from committees and staff and results of the ATM survey.

### Councilor McHugh suggested:

- Invest more in the senior center, \$10,000
- Peace Candle ~ design for Council to approve; integrate welcome to Scappoose sign goal
- Another park on the East side of town, property off of 6<sup>th</sup> & Vine/Elm Street/investigate property on E & S parts of town
- Move marketing & branding to short term goal list
- Purchase/select piece of art for 100-year event/commission piece of art

### Councilor Lesowske suggested:

- COVID business relief ~ direct people to those resources
- Partner with local University to study tree canopy (part of 50-year vision?)
- School Resource Officer ~ looking for funding options, alternatives
- Develop nature access plans/trails ~east side portion

### Councilor Poling suggested:

- Support for local restaurants ~ grants, information
- Annual meetings with School Board, County, Fire, Port, OMIC & Senior Center (one on one meetings)
- Continue Community Outreach ~ social media ~ additional transparency ~ post meeting videos to social media
- Parks & Recreation District ~ more information, pros/cons
- Parks Map on App
- Designate Vista as a park (formally) and Creekview?

### Mayor Burge suggested:

- Design downtown revitalization program (UR \$) \* incentives
- Review Development Code (business focus) social gaming, outdoor dining
- Burn law review (work with Fire District)
- Re-review food cart ordinance
- Council to review code

### Councilor Haugen suggested:

- Alternative Financing for City (discuss during sessions with other agencies)
- Reach 10% of community surveys (engage High School)
- Increase support for SBWC
- Scappoose will support trail to Tillamook project (articulate support)

### Council President Greisen suggested:

- Cosmetic/aesthetic standards for downtown
- Code enforcement
- Pool fund ~ determine costs

### Councilor Miller suggested:

- Sidewalk Plan
- Evaluate use of volunteer/neighborhood watch
- 2 police officers on 24/7
- Police Department operational needs analysis
- Public engagement campaign/effort post department head reports on website
- Update security system for water
- Work with 911 to assist with radio coverage issues
