Mayor Backus explained the agenda item regarding the update from Columbia County Department of Emergency Management will be moved to an agenda in March.



2025 ~ 2026 Strategic Plan ~ Council Goals

City Manager Burgener went over the 2025 ~ 2026 Strategic Plan ~ Council Goals. He explained we had a great retreat. He explained after the retreat Assistant to City Manager/City Planner NJ Johnson was tasked with putting together what was discussed that day into a packet, which is before you this evening. He stated NJ did a good job at putting it together. He explained what we are asking from the Council tonight is making sure staff captured what was discussed at the retreat.

Councilor Holmes explained she thinks the goals were captured really well. Her only recommendation would be on page 12 under next steps where it states there maybe periodic reviews of the progress, she feels it would be nice to define that there will be periodic reviews and maybe suggest a frequency so Council can hear how things are progressing.

City Manager Burgener explained they are usually updated in the department reports and then he already brings those as part of the topics any way so as opposed to having a set time, he tries to bring them up as much as possible. He said we can state there will be periodic reviews.

Councilor Haugen would like to have more specificity, which is why he sent the open Al synopsis. He would like that shared before they move forward.

Council President Miller feels this document is more of a statement of goals, not a strategic plan.

Councilor Lafrenz explained he agrees with Council President Miller that it should say City Council annual goals.

City Manager Burgener suggested it being updated to goals and priorities.

Councilor Jacobs moved, and Councilor Haugen seconded the motion that Council adopt the 2025 – 2026 the City Council strategic plan with the updates of the title of the document to City Council priorities and goals and the last sentence modified from there may be to there will be periodic reviews of progress.

She talked about attending Senator Ron Wyden's Town Hall and she found that session to be very informational. She stated it was a good reminder of how our process works. She encourages everyone to work our system and actively engage not only with our State legislatures but also engage with our current leader of the free world. She stated it is important for people to share their viewpoints that get to the White House on how things are affecting individuals.

Councilor Santiago stated it was a great Day at the Capitol. She also had the honor of attending the LOC conference. She would like to invite her fellow Councilmembers to join the Women's Caucus with her. She stated the event with Senator Ron Wyden was great, a lot of people attended.

Council President Miller thanked City Manager Burgener for setting up and facilitating the Council retreat.

Mayor Backus thanked the Police Department for helping at Senator Wyden's meeting. He explained Senator Merkley is here next Saturday in Clatskanie.
