

CITY OF SCAPPOOSE, OREGON REQUEST FOR PROFESSIONAL SERVICES PROPOSAL FOR

Water Financial Plan, Rate Analysis, and SDC Methodology Update

Proposals for the <u>Water Financial Plan, Rate Analysis, and SDC Methodology Update</u> project will be received by the City of Scappoose until **January 11, 2021 at 3:00 pm** via email at <u>hwhite@cityofscappoose.org</u>.

Introduction

The City of Scappoose is seeking professional services to develop a financing plan, rate recommendations, and updated system development charge (SDC) methodology for the City's water utility. This request is not a reflection on work done to date by any consultant or contractor on behalf of the City, rather, it is in the best interest of the City to receive multiple quotes and proposals pursuant to public contracting best practices.

The City of Scappoose is a municipal corporation of the State of Oregon located in Columbia County, OR. The City's water utility currently serves a population of approximately 7,686 people (with approximately 2,700 accounts) and obtains water from three surface water diversions and five permanent groundwater wells, with one new well under construction. The City's supply sources are treated at two treatment plants located at Keys Road and Miller Road.

The City recently adopted the 2020 Water System Master Plan Update¹ and is now ready to update its water financial plan, conduct a rate analysis. Additionally, the City needs to complete an update to its SDC methodology to reflect the master plan update. The most recent SDC methodology update occurred in 2002. The City intends to incorporate the rate and SDC methodology recommendations into its annual rate evaluation prior to the adoption of next fiscal year's budget.

Scope of Work

- 1. Financial Plan Update examine the City's financial capacity to complete the necessary capital projects as identified in the Water System Master Plan Update's Capital Improvement Plan and coordinate with City Staff to verify priorities.
- 2. Rate Analysis examine the City's utility water rate structure and provide rate recommendations pursuant to the Financial Plan
- 3. SDC Methodology Update develop the SDC reimbursement and improvement fees
- 4. Final Report prepare and present final report with recommendations to City Council
