- Please scan hand drawn logos and submit them electronically. Keep your original artwork, we may need to access it if your design is chosen.
- Minimum logo size is 6" x 6" inches.
- The logo needs to be clear and legible in sizes as small as 1" and as large as 12".

- Logo submissions will be accepted from January 31, 2021, to March 1, 2021.

- Include your full name, phone number, address, email address, and age with your entry. If you are a minor, please include your parent or legal guardians full name, phone number, address, and email address as well.
- Preference will be given to designs submitted from the Scappoose area.
- If winner is under the age of 16 the prize must be claimed by a parent or guardian.
- Winner will be notified by email no later than March 18, 2021.
- Submitted logos may be displayed on [scappoose100.com](http://scappoose100.com), the City of Scappoose Website, the City of Scappoose Facebook page, or in other media or platforms.
- Please limit entries to two per-person.

By submitting a logo you agree that your submission becomes the sole property of the City of Scappoose. Submitted logos may be post-produced by a design professional. The selection Committees and the City of Scappoose reserve the right to decline to select a winner from the submissions to this contest.
