City Council approves Temporary Outdoor Seating

On March 1, 2021, City Council approved Resolution 21-02 in order to establish a Temporary Outdoor Seating/Display Permit for businesses affected by Covid-19. The permit would allow a business in Scappoose to have an outdoor tented area for either seating or display of merchandise so that proper space between patrons can be achieved, and so that when indoor seating is not allowed based on the County's risk level, businesses can still operate and sell merchandise or food and drinks. The Temporary Outdoor Dining/Display Permit is intended to be in effect as long as the City's emergency declaration related to Covid-19 is in force.

POOL RELATED MONEY INFORMATION

Total balance of pool-related money available: \$57,183.52

Donated Pool Funds (formerly Swim Council and Bob Casswell Pool Funds): \$48,330.63

City Pool fund: \$8,852.89

This article is intended to describe: 1) where the pool funds are; 2) how much there is; and 3) why the donated pool funds ended up with the City.

Fundraising for a community pool dates to the early 1970's. Fundraising efforts began shortly after the passing of Bob Casswell, who had a vision to construct a community pool. The funds that had been raised were held in a private account by the Casswell Family. In the 1990's, the Scappoose Swim Council was formed as a charitable organization. The Swim Council's stated goal was to promote the construction of a community pool in Scappoose and support a competition level swim team. The Swim Council maintained their funds separately from the donations made to the Bob Casswell Pool Fund.

In 2009, the Oregon Department of Justice (DOJ) investigated the Swim Council for their failure to file a financial report. The DOJ found no wrongdoing or misuse of funds from either the Swim Council's account or the Bob Casswell Pool Fund. However, the State found that the Swim Council had become inactive and suggested they either dissolve or restart their charitable activities.

In 2012, the DOJ received a complaint that the Swim Council had misused funds. Another investigation was opened, but no wrongdoing was found. The DOJ recommended that the two privately held funds be transferred to an organization that could build the pool – the DOJ decided that the City of Scappoose receive the funds. In 2012, the Swim Council dissolved and their accounts, as well as the Bob Casswell Pool Fund, were transferred to the City.

In 2020, the City purchased a 9.5-acre parcel called the "Grabhorn Property." The property was purchased for \$731,600.08. That purchase was made from the City's dedicated pool fund. After the purchase, \$8,852.59 remained in the City's dedicated pool fund. Along with the donations that have been held since 2012, a total of \$57,183.52 remains earmarked for a pool.

Warmer weather is fast approaching, and the City would like to provide this friendly reminder that property owners are responsible for the following:

Sidewalks

Property owners are responsible for maintaining the sidewalks that abut their property. Additionally, the abutting property owner is liable for injuries that occur due to poorly maintained sidewalks that have become hazardous for pedestrians (SMC 12.04). If you are interested in repairing your sidewalk, please consider our Sidewalk Repair Program – a program to help cover 50% or up to \$1,000 of the repair costs, whichever is less. Vegetation and Trees

Property owners are responsible for maintaining vegetation at or near their property line, so that vegetation does not obstruct the street, sidewalk, streetlamp or intersection (SMC 12.12.070).

Fences

Fences of any kind are not allowed within the public right-of-way. If you are considering building a new fence, please see the "Fencing Quick Guide" on our website at: Fence info | City of Scappoose Oregon.

Visual Clearance Areas

Visual Clearance areas are important for corner properties where vegetation, trees, fencing or other items in violation of the visual clearance are can create safety hazards for pedestrians and vehicles (SMC 12.10).

Street Parking

Trailers, boats, and recreational vehicles (RVs) may not be parked on a city street for more than five days in a thirty-day period. No vehicles of any kind may be parked within fifteen feet of an intersection (SMC 11.04.170).

The Federal Emergency Management Agency (FEMA) recently approved a Letter of Map Revision (LOMR) which affects properties in the vicinity of South Scappoose Creek from approximately 955 feet upstream of NW EJ Smith Rd to approximately 2,200 feet upstream of EM Watts Rd. This LOMR will revise the Flood Insurance Study (FIS) report and the National Flood Insurance Program (NFIP) map, and the revisions will become effective April 19, 2021, provided no appeals are filed within the 90-day appeal period. Any request for reconsideration of the proposed mapping must be based on scientific or technical data.
