Old Portland Road Sidewalk Infill Construction Begins!



A new City construction project – **funded by the \$0.03 Scappoose Local Fuel Tax** – on Old Portland Road will deliver a safer, more accessible, and better-connected Old Portland Road for pedestrians and motorists. Construction began in late January and will continue through April. Over the next three months, the City's contractor will be constructing a number of improvements to the right-of-way, with completion expected by the end of Spring. The work will build new sidewalks and ADA sidewalk ramps, improve stormwater management, and establish a consistent roadway pavement width. These improvements are intended to enhance safety, accessibility, and community livability.

Please travel slowly and cautiously in and around work zones and observe directions by flaggers and temporary signage. Please expect intermittent traffic delays, dust, noise, and heavy equipment in active work zones.

<u>City of Scappoose</u> <u>Sidewalk Repair</u> <u>Program</u>

There are numerous areas of Scappoose where existing sidewalk sections that have degraded to the point where they create trip hazards for pedestrians. Sidewalks provide mobility for pedestrians, and connection to our schools, parks, and shops. Per City Code, property owners are responsible and liable for the condition of sidewalks that adjoin their property (SMC 12.04).

However, sidewalk repair can be costly. To help with the cost, the City initiated the Sidewalk Repair Program in 2020. Under the program, the City will pay for 50% or up to \$1,000 of the total cost of repairs, whichever is less, so long as a program application is submitted before the project begins and the repairs pass City inspection. This program is based on available funds and are provided on a first come, first served basis.

This is a friendly reminder that property owners are responsible for the following: **Sidewalks**: Property owners are responsible for maintaining the sidewalks that abut their property. Additionally, the abutting property owner is liable for injuries that occur due to poorly maintained sidewalks that have resulted in hazardous conditions for pedestrians (SMC 12.04). If you are interested in repairing your sidewalk, consider participating in the Sidewalk Repair Program: https://www.ci.scappoose.or.us/community/page/ sidewalk-repair-program-information.

Vegetation and Trees: Property owners are responsible for maintaining vegetation at or near their property line, so that vegetation does not obstruct use of the sidewalk or street. Property owners are responsible for maintaining the abutting parking or planter strip if one exists (SMC 8.20.100).

Fences: Depending on the type and height of the fence, additional requirements may be applicable. Please see the "Fencing Quick Guide" on the City website for more information about fences at: https://www.ci.scappoose.or.us/sites/default/files/fileattachments/building/page/727/fencing_quick_guide.pdf.

Visual Clearance Areas: Visual Clearance areas are particularly relevant to corner properties where vegetation, trees, fencing or other items can impede visibility for pedestrians and vehicles (SMC Chapter 12.10).

Street Parking: Trailers, boats, and recreational vehicles may not be parked on a city street for more than five days in a thirty-day period. No vehicles of any kind may be parked within fifteen feet of an intersection (SMC Chapter 11.04.170).
