COMMUNITY DEVELOPMENT CENTER

Building permits have been issued to WDC Construction for their 16-unit apartment complex on the corner of East Columbia and West Lane Rd. They are the owner, builder & property managers for the site. Remodel Permits were also recently issued to Community Action Team for 2 of their newly acquired senior apartments in Scappoose.

Three new commercial businesses have recently opened in Scappoose; O'Reilly's Auto parts store, Northwest Storage & Bi-Mart. Additionally, Papa Murphy's moved from Fred Meyer's storefront to Chinook Plaza.

We have several new subdivisions in various stages of review which are expected to begin construction sometime this year; South Fork (behind Fred Meyer's) an 88 unit Planned Development Subdivision, Dutch Canyon Estates Phase III (next to phase II) 35 lots, Pioneer Crossing (near SE 6th & Vine) 39 lots, and Five Peak Subdivision (top of NW Peak Rd, on NW Five Peak Terrace) 7 lots. Currently under construction is Unger Subdivision a 9 lot subdivision, which will extend NE Kale Street east to connect with North Road.

Tip of the month: Don't forget to check with the Building Department before beginning your construction project. There are zoning considerations and regulations for common spring projects like fences, decks & storage sheds.

SMOKE TESTING OF SEWER LINES

The City of Scappoose will be conducting test of its sanitary sewer system starting Mid July 2016. A "Smoke Test" survey will assist our inspection crews in locating breaks and defects in our sewer system. The smoke you see coming from the vent stacks on houses or holes in the ground is **NON-TOXIC**, **NON**

-STAINING, HAS NO ODOR, WHITE TO GRAY IN COLOR AND CREATES NO FIRE HAZARD. The smoke should not enter your home unless you have defective plumbing or dried up drain traps.

It is advisable for the homeowner to pour a gallon of water into each floor drain prior to our testing. If smoke enters your home there is good reason to assume that dangerous sewer gases may also be entering your home or business. You should evacuate immediately and notify City work crews. If you are not home and discover smoke when you return, please call us at 503-543-7146.

IMPORTANT! If there is any individual in your home or business who has respiratory problems and is immobile, please notify us at 503-543-7146 prior to testing.

CITY CODE CORNER

The Scappoose Police Department would like to welcome back Teresa Keller this year serving the department as our Code Enforcement Officer. Teresa was our part-time Code Enforcement Officer last year. In 2016 we have the opportunity to employ Teresa for the next five months.


She is passionate about teamwork, community engagement, emergency preparedness, and ensuring that safety is the #1 priority for the organizations she has worked for.
