Visit the historic Watt's House and check out the beautiful new upper roof! This much-needed re-roof was completed by Mark's Custom Exteriors and funded by a matching grant from the Oregon State Historic Preservation Office. The front porch will be re-roofed in dryer weather.

A Site Development Review application from WDC Construction for a 16-unit multi-family development, on the corner of E. Columbia Ave and West Lane Road, was recently received by the Community Development Center. This proposal will be heard by the Planning Commission in early February, 2016.

Additionally, a subdivision application for Pioneer Crossing Phase II is under review by the Planning Department. This 39 lot proposal is located east of the SE 6th St. & SE Vine St. intersection. This proposal will be heard by the Planning Commission in February, 2016 as well.

Planning Commission Meetings are held on the second and fourth Thursdays of every month, as needed. With so many proposals lately, the Planning Commission has been holding two meetings a month fairly regularly. During this very rainy season:

Check storm drain grates frequently to make sure they are free of leaves & debris.

DO NOT remove grates from the drain opening – this does not unclog the system and creates a hazard.

On December 12th the Scappoose Police Department organized a Krispy Kreme Doughnut Day benefiting the Scappoose Food Bank. After braving the rain and stormy conditions Scappoose Police Officers were able to sell 175 dozen doughnuts in 4 hours. Scappoose Police Department Receives Top Score on Risk Management Inspection

The City of Scappoose Police Department recently completed a Risk Management Plan that was a result of an onsite best practice inspection recently completed by CIS Insurance. CIS provides insurance coverage to nearly all Cities and Counties in Oregon. This inspection of the Department gave the Department a score of 96%. According to David Nelson, CIS Public Safety/Risk Manager Officer "this is an excellent result and one of the few law enforcement agencies in the state with such a high score." Nelson informed the Council that it was his opinion that the overall condition of the Police Department is very impressive. He stated that "it is one of the most well organized and clean Police Departments I have ever seen. The staff is all very friendly and pleasant to work with."
