# **City Updates Forest Management Plan**

The City of Scappoose recently hired Trout Mountain Forestry to complete a Comprehensive Forest Stewardship Plan, which was completed in December 2017, and was recently adopted by the City Council. The Forest Stewardship Plan looked at two tracts of land under City ownership with forest management needs; the Gourlay Creek tract of approximately 310 acres (which is outside of City limits and outside the Urban Growth Boundary) and the Vista tract of 76.61 acres, located within City limits.

The Gourlay Creek tract contains the majority of the City's watershed and by managing this tract responsibly it will help us to protect and enhance water quality and quantity and will provide a diverse forest and riparian habitat for fish and wildlife.

The Vista tract, which is zoned Public Lands Recreation and is located at the western edge of City limits between NW Bella Vista Drive and Luma Vista Drive, has experienced several blowdown events in recent years and as a result, there is an increased risk of wildfire from forest fuels, and access for firefighting is restricted because several of the access trails are blocked by down trees. This tract also contains two of the City's water storage tanks.

Following the recommendations within the Forest Stewardship Plan, the City recently applied for a Public Land Tree Removal Permit to allow for a salvage logging operation on the Vista tract to recover the down trees and to clear existing roads and trails for enhanced management access. Additionally, a light thinning of dense conifer is proposed in order to promote healthy vigorous growth and reduce future fuels accumulations. Thinning will focus on removing smaller, less healthy, or leaning trees. The Planning Commission approved the permit request during their meeting on April 26<sup>th</sup>.

Prior to the logging operation beginning, the City will post notices on their website and Facebook page to notify nearby residents of the proposed schedule.
