

Scappoose Police Department Media Release April 11, 2023

- 03012023 Police were dispatched to the report of an RV trailer leaking sewage in the 33000 block of NW Laurel St. Following the investigation, Tiffany Schmidt, 31, of Battle Ground, WA, was cited and released for Offensive Littering.
