ORDINANCE NO. 800

AN ORDINANCE VACATING A PORTION OF NE 2ND STREET

The City of Scappoose ordains as follows:

Section 1. Pursuant to ORS 271.120, that portion of the NE 2nd Street right-of-way consisting of the westerly 3.24 feet of the right-of-way abutting Lots 1, 2, 3, and 4 of Block 9, Watts Addition to the City of Scappoose, together with the easterly 10.63 feet of the right-of-way abutting Lots 5, 6, 7, and 8 of Block 8, Watts Addition to the City of Scappoose, as described on Exhibit A and identified by crosshatching on Exhibit B attached hereto and incorporated herein, is hereby vacated.

Section 2. Pursuant to ORS 271.120, the City reserves to itself and any operating public utility provider easements over the entire street right-of-way vacated by Section 1 of this ordinance for access, installation, maintenance, and repair of any existing or future public facility or public utility including but not limited to overhead or underground power or telecommunications lines, water lines, fire hydrants, sanitary sewer, and storm sewer.

Section 3. The following findings are hereby adopted in support of the above vacation:

- 1. On November 19, 2007, Council passed a motion to begin the process to vacate a portion of the NE 2nd Street right-of-way to conform to the width on adjoining development.
- 2. City Council has initiated vacation proceedings authorized by ORS 271.080 without consent of property owners pursuant to ORS 271.130(1).
- 3. The market value of the abutting property will not be substantially affected by the vacation because the property will not be deprived its current access to other streets and would not have had access to the right-of-way being vacated.
- 4. Notice of the proposed vacation was published in the *South County Spotlight* on June 4 and 11, 2008, as required by ORS 271.110(1).
- 5. Notice of the proposed vacation was posted on and adjacent to the site proposed for vacation on June 4, 2008 as required by ORS 271.110(2).
- 6. Notice of the proposal was mailed to affected property owners and residents on May 30, 2008.
- 7. A public hearing was held on June 16, 2008 and testimony was received for the record.
- 8. The public interest will not be prejudiced because the area vacated is not

needed for street right-of-way purposes and the existing improvements fit within the remaining 46-foot right-of-way width.

The City Recorder shall file a certified copy of this Ordinance with the County Section 4. Clerk, the County Assessor, and the County Surveyor of Columbia County, Oregon.

Passed and adopted by the City Council this 7th day of July, 2008, and signed by the Mayor and City Recorder in authentication of its passage.
