ORDINANCE NO. 801

AN ORDINANCE VACATING THE PORTION OF SE ELM STREET BETWEEN 2ND STREET AND THE RAILROAD RIGHT-OF-WAY

The City of Scappoose ordains as follows:

Section 1. Pursuant to ORS 271.120, that portion of the SE Elm Street right-of-way between 2nd Street and the railroad right-of-way in the City of Scappoose and described on Exhibit A and identified by the bold outline on Exhibit B attached hereto and incorporated herein, is hereby vacated.

Section 2. Pursuant to ORS 271.120, the City reserves to itself and any operating public utility provider easements over the entire street right-of-way vacated by Section 1 of this ordinance for access, installation, maintenance, and repair of any existing or future public facility or public utility including but not limited to overhead or underground power or telecommunications lines, water lines, fire hydrants, sanitary sewer, and storm sewer.

Section 3. The following findings are hereby adopted in support of the above vacation:

- 1. Dale and Patrecia Clark filed a petition to vacate this portion of Elm Street on or about May 2, 2008 in accordance with the provisions of ORS 271.080.
- 2. Written consent forms from the owners of all abutting property and from more than two-thirds in area of the affected real property were appended to the petition as specified by ORS 271.080(2).
- 3. Notice of the proposed vacation was published in the *South County Spotlight* on June 4 and 11, 2008, as required by ORS 271.110(1).
- 4. Notice of the proposed vacation was posted on and adjacent to the site proposed for vacation on June 4, 2008 as required by ORS 271.110(2).
- 5. Notice of the proposal was mailed to affected property owners and residents on May 29, 2008.
- 6. A public hearing was held on June 16, 2008 and testimony was received for the record.
- 7. The public interest will not be prejudiced because the area vacated is not needed for street right-of-way purposes and the street right-of-way terminates at the railroad right-of-way and all abutting properties would continue to have legal access from other streets.

Section 4. The City Recorder shall file a certified copy of this Ordinance with the County Clerk, the County Assessor, and the County Surveyor of Columbia County, Oregon.


