

RESOLUTION NO. 09-10

A RESOLUTION ESTABLISHING ALL FEES AND CHARGES FOR THE CITY OF SCAPPOOSE.

WHEREAS, the City of Scappoose wishes to ascertain and recover costs from providing City services, and

WHEREAS, the City Manager has caused a review of all City fees and charges and determined the cost for such services, and

WHEREAS, the City Manager has reduced certain fees in accordance with Resolution No. 09-04, and

WHEREAS, Scappoose Municipal Ordinances 563, 565, 566, 579, 634, 724, 725, and 731 gives the Council authority to adopt fees by resolution, now therefore

THE CITY COUNCIL RESOLVES AS FOLLOWS;

SECTION 1. THE ADMINISTRATIVE FEES ATTACHED AS EXHIBIT "A" INCORPORATES ALL ADMINISTRATION FEES, AND RATES FOR FISCAL YEAR 2009 – 2010 AND ARE HEREBY ADOPTED.

SECTION 2. THE POLICE FEES ATTACHED AS EXHIBIT "B" INCORPORATES ALL POLICE FEES, AND RATES FOR FISCAL YEAR 2009– 2010 AND ARE HEREBY ADOPTED.



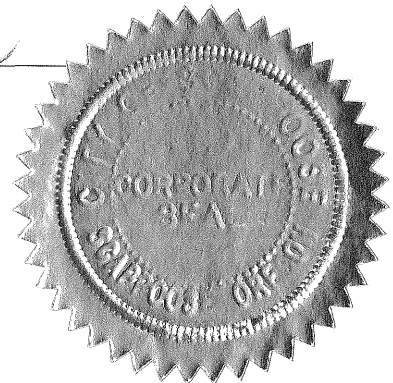
