

RESOLUTION NO. 10-18

A RESOLUTION EXTENDING THE COLLECTION PERIOD FOR THE STROBEL ADVANCED FINANCING REIMBURSEMENT AGREEMENT WITH THE CITY OF SCAPPOOSE UNTIL 2015.

**WHEREAS**, City of Scappoose, Municipal Code Chapter 3.20 established an Advanced Financing Reimbursement System; and,

**WHEREAS**, the ordinance provides for a ten year collection period, with the option for two five year extensions, granted in five year intervals; and,

**WHEREAS**, the City approved Resolution 00-06: A Resolution Establishing an Advanced Financed Improvement Relating to the Elm Street Crossing Water Line Project in 2000; and,

**WHEREAS**, Merrill and Rosanne Strobel have requested a reimbursement extension to the Elm Street Reimbursement Project until 2015.


**NOW, THEREFORE BE IT RESOLVED**, the City of Scappoose resolves as follows:

1. A five year extension for the Elm Street Crossing Water Line project is hereby approved.
2. The properties identified in Exhibit A of Resolution 00-06 (attached to this resolution) are subject to this Extension through October 2015.
3. This resolution shall be recorded in the deed records of Columbia County.
