## **RESOLUTION NO. 13-13**

## A RESOLUTION REVISING RATES FOR MONTHLY USE OF WATER SYSTEMS AND RESCINDING RESOLUTION NO. 11-19

WHEREAS, Ordinance 585 allows for Water Service Charges, and

**WHEREAS**, the Scappoose Public Works Advisory Committee held meetings to discuss the Water Department's budget and rate adjustments, and

**WHEREAS**, the City held a public hearing on the proposed water rate increase on August 19, 2013.

**NOW THEREFORE BE IT RESOLVED,** the Council hereby approves monthly Water Rates and Charges as follows:

## Section 1. Monthly Water Rates and Charges

- 1. Beginning November 21, 2013, water system users shall pay a minimum monthly charge of the following amounts:
  - (a) 3/4" or 1" meter: \$8.00 meter fee and a \$12.70 debt service fee, totaling \$20.70 per month (Residential).
  - (b) 1.5" or 2" meter not requiring maximum fire flow: \$35.00 meter fee and a \$55.44 debt service fee, totaling \$90.44 per month.
  - (c) 1.5" or 2" meter requiring maximum fire flow: \$59 meter fee and a \$93.48 debt service fee, totaling \$152.48 per month.
  - (d) 3" meter: \$164.00 meter fee and a \$259.82 debt service fee, totaling \$423.82 per month.
  - (e) 4" or greater meter: \$230.00 meter fee and a \$364.36 debt service fee, totaling \$594.36 per month.
  - (f) Any service outside the City, except Dutch Canyon area service: \$18.00 meter fee and a \$28.54 debt service fee, totaling \$46.54 per month.
  - (g) Dutch Canyon area service: \$12.00 meter fee and a \$12.70 debt service fee, as per 1984 court order, totaling \$24.70 per month.
- 2. In addition to the charges prescribed in subparagraph (1) above, beginning November 21, 2013, each user shall pay the following commodity rate structure for each 100 gallons of water used per month.

- 3. Beginning November 21, 2014, water system users shall pay a minimum monthly charge of the following amounts:
  - (a) 3/4" or 1" meter: \$8.00 meter fee and a \$17.70 debt service fee, totaling \$25.70 per month (Residential).
  - (b) 1.5" or 2" meter not requiring maximum fire flow: \$35.00 meter fee and a \$77.28 debt service fee, totaling \$112.28 per month.
  - (c) 1.5" or 2" meter requiring maximum fire flow: \$59 meter fee and a \$130.31 debt service fee, totaling \$189.31 per month.
  - (d) 3" meter: \$164.00 meter fee and a \$362.19 debt service fee, totaling \$526.19 per month.
  - (e) 4" or greater meter: \$230.00 meter fee and a \$507.93 debt service fee, totaling \$737.93 per month.
  - (f) Any service outside the City, except Dutch Canyon area service: \$18.00 meter fee and a \$39.79 debt service fee, totaling \$57.79 per month.
  - (g) Dutch Canyon area service: \$12.00 meter fee and a \$17.70 debt service fee, as per 1984 court order, totaling \$29.70 per month.
- 4. In addition to the charges prescribed in subparagraph (3) above, beginning November 21, 2014, each user shall pay the following commodity rate structure for each 100 gallons of water used per month.

- 5. Beginning November 21, 2015, water system users shall pay a minimum monthly charge of the following amounts:
  - (a) <sup>3</sup>/<sub>4</sub>" or 1" meter: \$8.00 meter fee and a \$22.70 debt service fee, totaling \$30.70 per month (Residential).
  - (b) 1.5" or 2" meter not requiring maximum fire flow: \$35.00 meter fee and a \$99.14 debt service fee, totaling \$134.14 per month.
  - (c) 1.5" or 2" meter requiring maximum fire flow: \$59 meter fee and a \$167.14 debt service fee, totaling \$226.14 per month.
  - (d) 3" meter: \$164.00 meter fee and a \$464.56 debt service fee, totaling \$628.56 per month.
  - (e) 4" or greater meter: \$230.00 meter fee and a \$651.49 debt service fee, totaling \$881.49 per month.
  - (f) Any service outside the City, except Dutch Canyon area service: \$18.00 meter fee and a \$51.03 debt service fee, totaling \$69.03 per month.
  - (g) Dutch Canyon area service: \$12.00 meter fee and a \$22.70 debt service fee, as per 1984 court order, totaling \$34.70 per month.

6. In addition to the charges prescribed in subparagraph (5) above, each user shall pay the following commodity rate structure for each 100 gallons of water used per month.

Section 2. Resolution No. 11-19 is hereby rescinded effective November 21, 2013.

**Section 3.** Unless a different rate is specified, the rates adopted above shall take effect on November 21, 2013.
