3. Announcements

- 3.1. Seely Lane Grant
 - 3.1.1. Alex Rains informed the committee that the city received \$450,000 for the Seely Lane Grant. Dave Powers offered to help unless the City feels it has gotten enough feedback from the Committee. He thinks there is great potential for the site and reiterated the need to focus on native planting.
 - 3.1.2. JJ thinks the apartments nearby would really benefit from the park being so close to the park. She used her own apartment building as an anecdote because she put in a garden and it increased the price of rent substantially.
- 3.2. S. Scappoose Creek Grant Update
 - 3.2.1. Dave Powers informed the Committee that Scappoose's OWEB grant was approved, but there wasn't enough funding, so Scappoose will not be receiving grant monies. He and the watershed council are working together on another grant with Bonneville that they are hopeful will get funded.
- 3.3. Other Announcements
 - 3.3.1. Ben asked that the committee attend public meetings for park related issues. There was a planning commission meeting that was very heated two weeks before this meeting and Ben would have loved to have support. The next two meetings were the upcoming City Council meeting on June 17th and Planning Commission on June 29th.
 - 3.3.2. Joel suggested that the committee should do some outreach at the farmers market. They could bring some of the maps and set up a tent. He wants to inform the community of the projects going on, and start to build support for the work they've done.
 - 3.3.3. Dakota announced that he is stepping down from the Parks and Recreation Committee because he no longer lives in Scappoose.
